Section 2	: <b>Product Composition (Classification)</b> The subject formulation is a nutrient blend of inorganic salts, organic compounds, amino acids, vitamins and carbohydrates. Phenol red is included as a pH indicator. After preparation in purified water, all ingredients are in concentrations of less than 1%.
Section 3	: <b>Hazards Identification</b> Hazard : Not classified as hazardous. No exposure limits established by OSHA or ACGIH.
Section 4	: <b>First - Aid Measures</b> In case of swallowing, wash out mouth with water provided person is conscious.
